



2011/2012 PartnersInGolf Incentive Program Annual Facility Authorization Agreement

The PartnersInGolf Incentive Program was launched to create a partnership between Bulls-i, Inc. and its golf facility customers. The goal is to provide off-invoice discounts or commissions to the partners enrolled in the program.

To enroll, the Facility Authorization Agreement must be completed on an annual basis and submitted to the Bulls-i, Inc. corporate office.

STEP 1

Select One Option

- Option 1** I own the golf shop operation at my facility and do not require employer/facility owner/club permission to receive off-invoice discounts or commissions from the Bulls-i, Inc. PartnersInGolf Incentive Program. I have printed and signed my name below.
- Option 2** I don't own the golf shop operation at my facility but can receive off-invoice discounts or commissions from the Bulls-i, Inc. PartnersInGolf Incentive Program. I agree, subject to eligibility requirements, that Bulls-i, Inc. will send any and all incentives earned from my participation in the PartnersInGolf Incentive Program to the payee name and address listed below. My employer and I both signed our names and completed all items below.

STEP 2

To receive off-invoice discounts or commissions, you must have a copy of this agreement on file with Bulls-i, Inc. The form must be completed and signed by you and your employer (if applicable) on an annual basis. Bulls-i, Inc. has the right to verify the signature and/or authorization of employers at Bulls-i, Inc.'s sole discretion, which may include but not necessarily be limited to, submitting copies of this form to your employer for verification.

How can the PartnersInGolf Incentive Program help you save money and generate additional revenue?

Example 1: You have an option to choose a 10% off-invoice discount for every order you place with Bulls-i, Inc.

Example 2: You can refer golf outing business to Bulls-i, Inc. and earn a 10% commission when an order is placed by the outing group.

Example 4: You can refer wedding party business to Bulls-i, Inc. and earn a 10% commission when an order is placed by the wedding party.

Example 5: You can refer homeowners to Bulls-i, Inc. and earn a 10% commission when an order is placed by the homeowner. For instance, a homeowner may want a kitchen tile backsplash, tile mural in their entryway, custom bar, etc.

All in all, you have two options as they pertain to the Bulls-i, Inc. PartnersInGolf Incentive Program. You can choose off-invoice discounts, which would allow you to educate, place orders, and invoice your contacts directly. This option will take up more of your time, but you have the ability to control the relationship from beginning to end. You can also choose to have Bulls-i, Inc. work directly with your referred contact. The Bulls-i sales team will take the time to work with your referral to make sure they receive orders on-time now and in the future. This option provides you with more time to handle golf facility tasks, but earn a commission along the way.
